MINUTES OF PROCEEDINGS AT SPECIAL MEETING OF THE MUNICIPAL DISTRICT OF ADARE-RATHKEALE HELD IN ÁRAS SEÁN FINN, NEW LINE ROAD, RATHKEALE, CO. LIMERICK ON TUESDAY, 14TH MARCH, 2017, AT 2.00 P.M.

1. <u>Policing Issues</u>

The Cathaoirleach welcomed everyone to the Meeting which had been called in order to look to the policing of Rathkeale during the Christmas period 2017 and with a view to resolving issues that had arisen during this period in 2016. Members highlighted the following law and order issues that escalate in Rathkeale during the Christmas period.

- Speeding, dangerous driving and traffic offences including the blocking of streets by vehicles;
- The unauthorised parking of temporary dwellings/caravans;
- The large number of unsupervised children at large on the streets in the evening and at night causing distress to the elderly and at risk of being knocked down by passing traffic;
- The extent of littering and dumping.

Members noted the large number of weddings held over the Christmas period, the extent to which the population increases and the need for visible extra Garda resources to cope with same. Members also noted the need for the Council to allocate a litter warden to Rathkeale for the period and the need to address the issue of unauthorised parking of caravans and unauthorised sites.

Chief Inspector Sheehan noted that Ballingarry Garda station, which had been closed for some time, had been reopened on 5th December, 2016. He reviewed the detected crime statistics for Rathkeale over the Christmas period which highlighted the extent of Garda activity and noted that 60 overtime tours had operated over a 3 week period, as well as successful Criminal Assets Bureau (CAB) operations. He noted the need for the Council and the Gardaí to come together to identify the issues that each had the legal powers to address and stressed that the Gardaí could only act within the law.

Members noted that byelaws had been put in place regulating the use of temporary dwellings in Rathkeale and stressed the need for a facilitator to be put in place, as agreed, to identify the full range of issues to be addressed.

The Cathaoirleach thanked the Gardaí for their contribution and commitments and looked forward to further meetings in this regard.
